LEGISLATIVE INITIATIVE



FOR THE ESTABLISHMENT OF SANCTUARIES AND CENTRES FOR THE REHABILITATION AND REINTEGRATION OF MARINE MAMMALS AND THE PROHIBITION OF CAPTIVE BREEDING FOR RECREATIONAL PURPOSES

- 1. Prohibit breeding for entertainment purposes in captivity.
- 2. Regulate measures and create confinement spaces for marine mammals in sea pens, the tanks will only be used in natural disasters as a shelter or quarantine.
- 3. Activities with marine mammals are limited to observation, snorkelling and scuba diving in open spaces only.
- 4. Prohibiting forced and conditioned interactions with humans. Avoiding diseases known as zoonoses to be transmitted from animals to humans and viceversa.
- 5. Information on marine mammal management will be made public and research programmes will be carried out for rehabilitation purposes to create Marine Sanctuaries.



OBJETIVE

- Achieving a model shift from UMAS and PIMVS to Marine Sanctuaries and Rescue Centres for Rehabilitation
 - Respectful Mexico, Attracting sustainable ecotourism

CURRENT SITUATION

- More than 450 specimens in confinement.
- No constant supervision and monitoring by PROFEPA& SEMARNAT DGVS.

PROBLEMATIC

Exploitation of dolphins and sea lions for training, precarious swimming pool facilities in hotels and sea pens. Risks to human and animal health/ Zoonosis and COVID Confidentiality agreements due to trade secrets of dolphinaria.

ALTERNATIVE & PROPOSED LAW

- Modification of the NOM-135-SEMARNAT-2004 of reproduction of marine mammals and Art 60 y 78 bis LGVS, Codigo penal Art. 420.
- Create sanctuaries at sea for rescue and reintegration in alliance with research centres and local ecotourism communities.

DEVELOPMENT

Make changes to improve the situation

- Laws: Prohibit Exploitation and Abuse and entertainment with marine mammals in Mexico.
- Construction of phased sanctuaries / Opportunity to change the dolphinarium model in Mexico.
- Develop international alliances for research projects for reintegration and their study in free living, education and conservation.

Sanctuaries and rescue centres in Indonesia, Brazil, in process Canada, France, Italy and USA.

PERMITTED ACTIVITIES

In Marine Mammal Sanctuaries and Research, Rehabilitation and Reintegration Centres



ECO TURISM

Diving, snorkelling and remote observation activities without direct interaction. Established schedules and in open spaces and sea pens.



REHABILITATION

Rehabilitation and reintegration activities in their natural habitat by certified researchers.



RESEARCH

Academic research that does not endanger their physical and emotional health and integrity and contributes to the aims of the Marine Sanctuary.



EDUCATION

Observation and guided tours for educational purposes without human interaction of any form

Law Initiative for the Creation of Sanctuaries for the Rehabilitation, Rescue and Reintegration of Marine Mammals in Captivity in Mexico

1. REPRODUCTION

Prohibit breeding for captive training purposes.

2. CONFINEMENT

Regulate measures and create confinement spaces in sea pens.
Pools remain in exclusive use for natural disasters..



3. ACTIVITIES

Activities are limited to observation, snorkelling and open water diving.

4. INTERACTIONS

Prohibit forced interaction and human contact.

5. PUBLIC INFORMATION

The information and management will be public and will carry out research programmes.



- 1. Prohibir la reproducción con fines de entretenimiento en cautiverio.
- 2. Regular las medidas y crear espacios de confinamiento de mamíferos marinos en corrales de mar, los tanques únicamente serán utilizados en desastres naturales como resguardo o en cuarentena.
- 3. Las actividades con mamíferos marinos se limitan a la observación, snorkel y buceo en espacios abiertos únicamente.
- 4. Prohibir las interacciones forzadas y condicionadas con humanos. <u>Evitando las enfermedades transmitidas de animales a humanos y viceversa conocido como zoonosis.</u>
- 5. La información en el manejo de mamíferos marinos será pública y se llevarán a cabo programas de investigación con fines de rehabilitación para crear Santuarios Marinos.
